<u>Abstracts</u> will include a short summary of your research and will be limited to 300 words. The abstract will be used to determine if your research is fit for this presentation style and will guide the reviewers in making a decision if your presentation will proceed (see the Abstract Acceptance guidelines).

A <u>poster</u> on the other hand will include all of the information and data from your research in a presentation style format that will allow attendees of the conference to obtain information regarding your study. This will be a more informative style of presentation and is your opportunity to show the knowledge you have gained towards your chosen topic.
